In the second topic, we will learn the theory of capital structure and the capital budgeting for the levered firm. In the third topic, we will learn the corporate payout through the theory of dividend policy. The fourth big topic is the introduction of derivative and how they are used in corporate finance. Finally, we briefly introduce the corporate control in mergers & acquisitions.
