### 課程介紹

「誰的知識」(whose knowledge)，是當代女性主義學者的重要提問。這個提問揭露了知識的位置性與政治性，也推動著性別研究乃至於社會理論的轉變。晚近，性別範疇與壓迫結構的普同性遭受挑戰，多重交織與相互構成的的權力關係則成為一個重要思考路徑。另一方面，後殖民與跨國的視野不僅將性別放置回較大尺度的政治、經濟與文化脈絡之中，亦鼓勵反思西方中心的知識生產。

這門課希望帶給同學一個性別社會學的基礎認識，並提供以性別觀點進行社會分析的思考工具。課程內容大致分為兩部分：第一部分回顧一些重要概念與理論發展，第二部分則討論性別與其他權力軸線如何共同形塑各種社會制度、行動，以及人與自然的關係。

### 課程要求與評核

- 課堂參與和導讀 (30%)：請於課前閱讀當週指定文本，並於課堂上參與討論。也請同學輪流導讀文本。
- 讀書紀要 (35%)：請撰寫至少七篇文本閱讀紀要，並於上課前一天繳交。閱讀紀要的內容包括文本的論點、文本作者如何進行論證，以及同學對於文本的想法和提問。
- 學期報告 (35%)：請撰寫一份學期報告。這份報告的立意在於協助同學的研究或學習，形式彈性，可以是一份小研究、研究計畫書，或文獻評述。繳交時間為課程結束後的一週。
- 旁聽的同學請分擔課堂導讀。
- 本課程為 16 週課程，同學須參與學期間安排之相關演講，課程結束後亦須撰寫期末報告。
